

# Instructions for Gaining Access to NATO Unclassified Sessions

## 19<sup>th</sup> International Symposium on Interaction of the Effects of Munitions with Structures (19<sup>th</sup> ISIEMS)

Please note:

If you have permission to attend the NATO sessions, you automatically have permission to attend SHIELD sessions. If you wish to apply for SHIELD sessions only, please refer to our webpage for the according form.

To ensure that only properly qualified ISIEMS participants gain access to NATO unclassified technical papers and presentations at the 19<sup>th</sup> ISIEMS, the following steps are **ESSENTIAL**:

1. The “NATO SESSION ATTENDANCE FORM” on the next page must be completed and submitted to [isiems@Bundeswehr.org](mailto:isiems@Bundeswehr.org) prior to attending the conference. All attendees wishing to attend NATO unclassified sessions must complete and submit the form. Attendees who are not directly employed by a NATO defense agency (contractors, civilians of non-defense agencies, etc.) must have a NATO defense agency endorser complete Part 3 of the form, requiring their signature. This indicates to the 19<sup>th</sup> ISIEMS organizers that a contractor or non-defense agency civilian has legitimate need and purpose to attend the NATO unclassified sessions.
2. Upon registration, please present a passport or identification card. You will be provided with a badge, which allows you to enter NATO and SHIELD sessions.
