Koblenz is also located 200 km northeast to Gadheim, which is the geographical center of the European Union.

Cooperation and CivMil Engagement for Resilience in Alliance Defense

The MMCC/EMC is a multinational coordinating entity within the field of medical support, facilitating the provision of military operational medical expertise for its participating nations as well as the EU and NATO.

It offers to NATO a platform and network for cooperation with facilities/ organisations outside NATO within the framework of civilian emergency.

MMCC/EMC's aim is to strengthen civil-military medical cooperation and medical resilience. With this goal in mind, we intend to hold a hybrid workshop in KOBLENZ from 17 till 21 July 2023 on the following topic:

"Medical resilience in the field of civil-military cooperation"

#### **TOPIC**

The workshop will focus on the possibilities of the cooperation between civilian and military medical enablers and institutions in the event of an Article 5 crisis.




## **ASPECTS**

The following aspects of civil-military cooperation are on the agenda:

- Exchange of civilian/military patients in the area of operations and their home countries
- MEDEVAC (cross-border) and patient flow management
- Coordination and communication between individual medical actors (civilian and military)
- Exchange of surge capabilities

The cooperation and coordination of military and civilian actors in the host country will be in the foreground with the aim of identifying capability gaps and harmonizing interaction.

Another priority will be the role of national and international institutions, e.g. the European Commission (DG ECHO, DG MOVE), the International Red Cross (POW, Tracing Service) or the United Nations (UNHCR, WFP) in the case of an Article 5 scenario.



## **OBJECTIVES**

What can be specifically derived and transferred from the experience of previous international crises, conflicts and disasters in the case of an Article 5 crisis? Where should or would we have to rethink?

Our aim is to take up and discuss the questions of individual actors from politics, the military, disaster management and civil protection as well as national and international governmental and non-governmental organisations. Thus we can mutually benefit from the differences and commonalities identified and are well prepared for future challenges.
