## **BwVC Student Information**

Welcome to the Bundeswehr Verification Center (BwVC)! We hope that your attendance will be rewarding both in personal and professional terms. Before your trip, we would like to offer some useful information that will help make your stay here more enjoyable and trouble-free. Together with the allocation of a training course slot (confirmation of participation), we are going to send you more detailed information on the training course in question.

### **1. IMPORTANT PACKING AND TRAVEL NOTES**

#### **Security clearance**

You DO NOT NEED any security clearances for the courses.

#### **Travel order**

You DO NOT NEED any NATO travel orders or national travel orders.

#### **Visa arrangements**

If a participant needs a visa to enter Germany, he/she will be responsible for obtaining the visa himself/herself. BwVC will provide an official letter of invitation upon request.

### **2. PRE-COURSE PREPARATION**

At the moment there is no requirement for pre-course online preparation.

### **3. ARRIVAL AT GEILENKIRCHEN**

You must arrive at the City Hotel in Geilenkirchen for check-in procedures between 15:00 and 21:00 hours on the Sunday prior to class. Your class start times, course schedule and transportation schedule will be given to you during the check-in on Sunday.

If it is not possible to arrive within the specified time, please contact the BwVC Student Administration Office (+49-2451-992-4501) before 12:00 hours on the Friday prior to the beginning of the course and, if your accommodation is there, the City Hotel. In addition, you should report to the Student Administration Office on the first morning of the scheduled classes at 08:00 hours.

If you arrive on Sunday after 21:00 hours, please contact the City Hotel as there is a specific procedure for your check-in.

Most of the BwVC courses run from Monday through Friday. If your course ends on a Friday, the ceremony to hand out the certificates will normally take place around 11:30 hours. Please do not plan your departing flight from Duesseldorf before 15:00 hours.

#### **4. ACCOMMODATION**

Since there is no military accommodation available, we have reserved rooms at the City Hotel in Geilenkirchen. After receipt of the course slot allocation, every participant has to book a hotel room himself/herself or via his/her responsible agency by email ([office@cityhotel-geilenkirchen.de](mailto:office@cityhotel-geilenkirchen.de)). It is absolutely necessary to indicate "BwVCTraining" as a reference for the reservation. Accommodation costs have to be paid by the participant himself/herself. The price of a single room with breakfast will be EUR 86.00 a night. Please do not use commonly accessible internet portals for booking your room since in that case you will not be able to benefit from our special rates. #### **5. TUITION PAYMENT**

#### **6. MEALS**

Breakfast is served at the hotel starting at 06:30 hours (Monday – Friday). During the training course, lunch is provided at the BwVC dining facility. Participants with special dietary requirements for religious, health or other reasons are requested to inform us accordingly in advance. Participants will have to make their own arrangements for supper.

#### **7. OTHER EXPENSES**

The following miscellaneous costs may arise for course participants, depending on the options they choose:

## **8. SECURITY PROCEDURES**

You are allowed to bring mobile phones, PDAs, cameras or any other recording device into Selfkant Barracks. However, the devices must be switched off in all classrooms, syndicate rooms and in the Academic Building.

## **9. DRESS CODE OR UNIFORM REQUIREMENT**

The standard dress for the courses is your regular uniform (duty or field uniform). Civilian dress may also be authorized by the Course Director for certain occasions or during periods of high alert status. In these cases, students will be advised accordingly.

There is a no-hat policy within the barracks (no obligation to wear headgear).

## **10. TRANSPORTATION**

You are required to make your own arrangements for the trip to and from BwVC. Please be aware that courses may be cancelled or course dates may be changed up to 5 weeks prior to the beginning of the course.

BwVC will arrange transportation from and to Duesseldorf Airport. Upon your arrival, a staff member with a BwVC sign will be waiting for you at the exit. In case you fail to meet him/her, you can contact us at the 24/7 emergency number +49-2451-992-4444 (BwVC Ops Center).

Daily transport from the hotel to Selfkant Barracks (BwVC) and back will also be provided by BwVC for the course participants. In the morning, the bus will leave at 07:50 hours from the bus station in front of the hotel. The return trip will be in accordance with the course schedule.

If you are traveling with your own vehicle, you are allowed to enter the barracks and you may park your vehicle in the designated area which is signposted.

## **11. SOCIAL EVENTS AND ATTIRE**

Some social events have been planned for the courses. The dress code for those events may be duty uniform or casual civilian dress.

## **12. WEEKEND ACTIVITIES**

During a two-week course, a weekend event may be offered if a sufficient number of participants want to take part. Participation is voluntary. ## **1. Background**

The Treaty on Conventional Armed Forces in Europe (CFE Treaty) has been in force since 9 November 1992. The main objectives of the Treaty, which was negotiated by the member states of the former Warsaw Pact and NATO, are as follows:

- Establishing a secure and stable balance of conventional armed forces in Europe at lower levels; and
- Eliminating disparities and the capability for launching surprise attack and for initiating large-scale offensive action in Europe.

The exchange of relevant information and the verification of such information by mutual inspections are essential instruments for the implementation of the Treaty.

The CFE Treaty is an integral part of Europe's security architecture and is closely intertwined with other treaties and agreements. Its proactive application and proper implementation support the fine-meshed security structures in Europe.

## **2. Course aim**

The course is designed to qualify the participants to perform the duties of an inspector or escort in preparing and conducting CFE inspections. Participants must therefore be able to:

- Explain the structure and procedures of the information exchange;
- Obtain information about an object of verification from the exchange of information and relevant notifications;
- Exercise the rights and perform the duties of an inspector or escort during an inspection; and
- Record the information obtained in the inspection report after conclusion of the inspection.

## **3. Venue**

Bundeswehr Verification Center in Geilenkirchen, Germany; for the practical exercises: objects of verification within Germany or abroad.

## **4. Participants**

Military personnel and civilian members of verification organizations as well as secondary-function arms control personnel.

## **5. Methodology**

The course topics will be taught in a logical order. Two practical exercises (training inspections) will complement the course.

## **1. Background**

The Vienna Document 2011 (VD11) is composed of politically binding confidence- and security-building measures (CSBMs) designed to increase openness and transparency on military activities conducted within the OSCE zone of application. The zone of application covers the territories, adjoining sea areas and air space of all European and Central Asian participating States, including Russia from its western border to the Ural Mountains. Various information exchanges, on-site inspections, evaluation visits, observation visits, and other military-to-military contacts take place in the framework of VD11 provisions.

## **2. Course aim**

The course is designed to train the registered participants in, and qualify them for the performance of, the tasks of an inspector, evaluator, observer and escort in the field of verification according to the VD11. This will enable them to exercise their respective rights and perform their duties as a member of an evaluation or inspection team.

Specific objectives:

Upon completion of the course, participants will be able to

- describe the confidence- and security-building measures provided by the Vienna Document and the associated duties of personnel involved in their implementation;
- plan, coordinate, conduct, and report about VD11 observation activities, evaluation visits and CSBM-related inspections in specified areas as a member of a national or multinational team; and
- apply the provisions of the VD11, plan, coordinate and escort evaluation visits, inspections, other visits and observation activities as a member of a Vienna Document escort team.

## **3. Venue**

Bundeswehr Verification Center in Geilenkirchen, Germany; for the practical exercises: military installations in other countries.

## **4. Participants**

The course will be open to all OSCE participating States which have a verification organization.

It has been designed for individuals with duties in the field of arms control, i.e. for military and civilian members of verification organizations as well as for secondary-function arms control personnel assigned to ministries of defense, arms control agencies or ministries of foreign affairs of OSCE participating States. The number of participants is limited to 20.

## **5. Methodology**

The two-week course includes interactive plenary lectures, followed by brief moderated Q&A sessions. Additional lecturers from other verification agencies, the OSCE and ministries of defense of other countries provide supplementary points of view.

Several syndicate work periods (group-based discussions, problem solving, exercise participation, etc.) and two training evaluation visits are included to promote student team building and consolidate the knowledge gained.

## **6. Language skills**

Participants should have a Standardized Language Proficiency (SLP) of 2221 (or higher) in English, as described in STANAG 6001, or comparable skills.

**(SALW/AV Course)**

## 1. Background

Surplus stockpiles of small arms and light weapons (SALW) pose significant hazards to people, the environment and the security of countries. The UN and various regional organizations therefore address these problems with many initiatives, with the common aim to decisively improve the current situation through international cooperation and assistance. This may include financial and technical assistance, as appropriate, to support and facilitate efforts at the local, national, regional and global level.

There are several crucial thematic areas in the field of international assistance and cooperation that focus on reducing destabilizing accumulations and combatting the uncontrolled spread of SALW as well as on preventing illicit trafficking in SALW:

- Reduction of global surplus SALW stockpiles;
- Containment of the illegal spread of SALW; and
- Promotion of proper management and security of national stockpiles.

The Multinational Small Arms and Ammunition Group (MSAG) has assumed the tasks of promoting capacity-building for physical security and stockpile management (PSSM), sharing best practices with regard to SALW and orchestrating destruction and disposal in order to reduce accidents and the number of SALW in circulation.

The MSAG is an apolitical, unofficial, multinational group of like-minded nations. At the discretion of its member states, it undertakes the development of SALW-related SOPs and training programs deemed necessary to improve the quality of efforts made in the field of SALW.

## 2. Course aim

The members of an assessment visit (AV) team need to have an understanding of the hazards and consequences of improperly stored and inadequately managed SALW stockpiles. This will ensure the personal safety of the team members and improve the effectiveness of the AV. The AV team members should have the relevant expertise in the field of technical and administrative safety and security of SALW storage. They should be able to work with national governments and relevant organizations to conduct a comprehensive assessment of the organization of a state's management of SALW, including storage facilities, before providing recommendations for actions to be taken to improve the organizational structure as well as safety and security on site.

## 4. Participants

Military personnel and civilians of national and international organizations, predominantly from MSAG nations, who will be tasked to carry out assessment visits to states in the field of weapons and ammunition management and/or to conduct training courses on combatting the illegal spread of arms as well as on physical security and stockpile management.

Participants should have a Standardized Language Proficiency (SLP) of 2221 (or higher) in English, as described in STANAG 6001, or comparable skills.

## **2. Course aim**

The course is designed to enable participants to recognize and identify conventional armaments and equipment subject based on the former CFE Treaty as well as major weapon and equipment systems, so that they will be able to verify the information provided in the various information exchanges during inspections and evaluations in other countries.

## **3. Venue**

Bundeswehr Verification Center in Geilenkirchen, Germany.

## **4. Participants**

The course will be open to all NATO member states, plus Austria and Switzerland, with a verification organization.

The course is designed for individuals with duties in the field of arms control, i.e. for military and civilian members of verification organizations as well as for secondary-function arms control personnel assigned to ministries of defense, arms control agencies or ministries of foreign affairs of NATO member states plus Austria and Switzerland.

The number of participants is limited to 20.

## **5. Methodology**

This two-week course includes interactive plenary lectures followed by short tests at the beginning of the next day to check the level of knowledge. There will be no exam and no performance assessment.

Additional lecturers from other verification agencies and organizations from other countries provide supplementary points of view.

## **6. Language skills**

Participants should have a Standardized Language Proficiency (SLP) of 2221 (or higher) in English, as described in STANAG 6001, or comparable skills.

## **1. Background**

The Treaty on Open Skies (OS Treaty) is one of the confidence-building measures designed to strengthen openness and transparency of activities among states. Its area of application currently comprises the territories of 32 States Parties. The Treaty permits observation flights that are carried out using clearly defined and certified sensors. Observation flights are always mutually agreed by the States Parties involved, and the observed State Party participates in the relevant activities.

## **2. Course aim**

The course is designed to familiarize participants with the planning and conduct of missions, using the German Airbus A319 OH aircraft as an example, and to enable them to fulfill their duties and exercise their rights in a potential active/passive role or as a member of a joint OS mission.

After completing the course, participants should

- be able to describe the confidence- and security-building measures set out in the Treaty on Open Skies as well as the resulting responsibilities of the personnel involved in those measures;
- have acquired knowledge about the preparation and conduct of an observation flight as well as about the related reporting; and
- be able to take the parameters of an observation aircraft into account when planning shared flights or flights involving a lease option, using the A319 OH as an example.

## **3. Venue**

Bundeswehr Verification Center in Geilenkirchen, Germany, as well as other national military installations that are used to conduct an observation flight.

## **4. Participants**

The course may be attended by personnel from all OS States Parties and associated states.

It has been designed for members of verification organizations; the number of participants is limited to 14.

Prior attendance of the Open Skies Orientation Course at the NATO School Oberammergau is generally desirable.

## **5. Methodology**

The two-week course comprises interactive presentations on the fundamentals of the OS Treaty and the applicable decisions as well as the preparation and conduct of one or more OS observation flight(s).

Syndicate work periods and practical conduct of flight activities are also included to consolidate the theoretical knowledge gained and to strengthen confidence in the OS observation platform provided.

Additional instructors from other States Parties provide supplementary points of view.
